CHURCHWARDENS' REPORT

We have had a very busy year at All Hallows, with lots of regular use of the church.

With Reverend Mic recovering from his surgery we have been very lucky to continue to hold 3 communion services each week; many other churches are not so fortunate. Other services have continued, throughout the year, including a full range of services at Easter and Christmas, plus Remembrance Sunday, the Annual Commemoration Service, Weddings and especially Baptisms. We thank everyone who has contributed to this, especially Reverend Jean Lamb and Reverend Keith Williams.

We are also lucky in our team of Readers, Maureen Staniford, Margaret Hicking, John Tattersfield and John Rigby.

We are not leaving Reverend Mic Johnson out, as despite his surgery, he has really pushed himself to officiate at services, often when he would have been wiser to rest his eyes. Their conscientiousness has meant that we have only occasionally needed to arrange for visiting clergy.

The Heart of All Hallows Church has to be you, the congregation and visitors. We had a class visit earlier this month from All Hallows School, some of the questions being asked, really tasked us to answer, especially how many people use church? How many are paid? (quite easy, very few), and how many people volunteer? This last one was really difficult to answer as there are so many people who give freely of their time, in all sorts of ways, I think that John and I gave up when we reached around 200

people, from welcomers, cleaners, servers, flower arrangers, magazine distributors, etc. (sorry if you are part of the etc.) We owe a huge thank you to you all for your commitment, and the willing and loving way that you carry out so many jobs.

The Wednesday opening is one of these commitments, it is such a welcoming time with friendship and reminiscence. It is remarkable to see the variety of people who visit church; frequently strangers who have seen that the church is open and are in need of support and friendly company.

During the year we have had visits from various organisations such as local U3A's and especially the local schools who have all experienced the history and welcome that we offer in All Hallows.

The new Garden of Remembrance is now available with some interments taking place.

Other regular services are for Weddings and Baptisms and we are very pleased to welcome everyone who wishes to celebrate their special day in All Hallows.

As we write this we have the planned refurbishment taking place with the addition of an extra toilet and servery. Thank you to all who have worked in the planning of this and in the raising of funds.

As we go to press, we have the national emergency of Coronavirus when we have needed to suspend regular services, yet still keep in touch and care for each other.

We pray for God's Blessing on us all.

MINUTES OF THE ANNUAL PAROCHIAL CHURCH MEETING HELD ON TUESDAY 9TH APRIL 2019 IN ALL HALLOWS CHURCH

Apologies were received from Revd Mic Johnson, Revd Jean Lamb, Noreen Burrows, Dorothy Martin, Dorothy Parr, Mick Pringle, Pat Taylor, Pam Tunicliffe, Dorothy Wardle, Eleanor and Rick Wilson.

- 1. Minutes of the last Meeting:** there were no points of correction and the minutes were accepted as an accurate record.
- 2. Rector's Report:** Due to Mic's ill health there was no Rector's report

3. Electoral Roll Report: Keith Hollingworth reported that there had been 167 names on the previous Electoral Roll. The New Roll contains 124 names at the time of closing.

4. Election of PCC Members: Two members had completed their terms of office: Ted White and John Rigby. For the five vacancies there were four nominations who were duly accepted; Graham Francis, Orla Mills, Steve Hicking and Pat Yarnall for the term 2019 - 2022. Anthony asked us to pray for them. There remains two vacancies for the 2017 term and four vacancies on the 2018 term.

Deanery Reps. Thank you to those who represented us. Janet Grinnell, Rick and Eleanor Wilson. They would continue for the coming year. Anthony Giles mentioned the sterling work done by David Yates.

5. Treasurer's Report: A report and the Statement of Financial Activities and a Balance sheet for 31st December 2018 had been circulated in advance. The accounts had been audited by D.G. Hollingworth and were duly accepted with grateful thanks to Eleanor for her work as treasurer.

6. Reports from Church Organisations: The reports were open for comments and Anthony Giles celebrated the many diverse activities that were included. He thanked all involved. Maureen Staniford suggested that we use our booklet to present to new people. June Gent thanked everyone for their work. Thank you to all the sides-persons who welcomed everyone to our services. They are our 'shop window' and their smiling faces were a great encouragement.

7. Resolutions to PCC:

Keith Hollingworth had two resolutions:

i. What was being done with the kneelers currently stored above the vestry?

Gillian answered that suggestions had been made but more needle workers were needed.

ii. Green Energy. Could solar panels be placed upon the roof?

RECTOR'S REPORT

"To everything there is a season."

The first thing for me to say to all of you is a big **THANK YOU**

Thank you to the more than one hundred volunteers who keep this amazing building alive and functioning, from the practical to the spiritual all of you are an amazing team and a blessing to Gods kingdom.

On a personal point I would like to thank you all for your love, prayers and support over the last year following on from my cornea graft, the healing continues and I'm trying to take it one step at a time but that's enough of that.

As you read through this APCM report you will see how much we as a church have achieved over the last year, you will also see how many long planned projects are on the way to being fulfilled, whether it's the redevelopment of the back of church, the sound system or the going improvements to the memorial hall. Thank you to all have been involved in these projects, from the committees to the fund raisers.

As these developments are finished it will present us with opportunities to think about how we use these buildings in new ways, opening it up to our communities, looking for ways engage with them and bring them in. Maybe we can take some pointers from Christmas Tree lighting event which bought so many people into the church.

The other missional challengers for us is to be seen out in our community, this can seem daunting but we have started we with events like the sunrise service at Easter, Beer and Carols in our local pubs and joining together with other local churches to be seen worshipping together in the community and in each other's churches.

One of the great sources of witness this year was the stable by the tree at Christmas, this provided a statement of witness to not just our community but to all who passed the roundabout. the reaction to it was so positive, many commented on it and said wonderful it was to see it. Thank you to all involved.

As always however there are some realities that do need to be faced:

1: MONEY

The project budget this year will leave us short of funds, our reserve is running low. Nothing that is on the budget is extravagant and it's hard to see how we can trim it any further. The reality remains that it takes about £2000 a week to keep the church open. I would ask each of you to prayerfully consider your giving, if you pay taxes remember whatever you give, we can claim back some additional income form the government.

2: TIME

We need more volunteers to help with the running of the church, whether social and fundraising events, Junior Church, our services or maintenance of the building. God has given all of us gifts to use and how wonderful it would be to use some of those gifts for God and his work here in Gedling.

The family of Gedling Church is an incredible blessing to so many, as a family we continue to grow together as we support each other and reach out into our community. I bless you and thank you for all you do and will continue to do, for the worship we share together and for the wonder of knowing a God who love us so much he gave his son to save us.

ELECTORAL ROLL REPORT

For the APCM in April 2019 a new Electoral Roll under law had to be commissioned. 124 people elected to have their names entered onto the Electoral Roll in readiness for the APCM, which was accepted by the PCC. During the period April 2019 to 31st December 2019 there has been one addition. The number on the Electoral Roll now stands at 125.

TREASURER'S REPORT

At the end of 2019 we carried forward a working balance of £3325 which showed a deficit of £4700 compared with the working balance at the end of 2019. We paid all our bills and our Giving for Ministry in full, but we had to reduce our current account balance to do so.

We received two very large legacies totalling £82244 now held in the Capital Reserve account, plus a recent legacy of £1000 and grants for the tea bar of £7700 held in the high interest account. We have further pledges of grants for the tea bar project (£8300), VAT returns on the majority of the work, and fund raising from The Friends of All Hallows (£36,000) the balance of £37,000 will come from the legacies.

We have also been fund raising for the proposed sound system, so far £417 has been raised with more events planned for 2020. The total cost of this is expected to be around £13,000, but as it is so urgently needed, the work will go ahead as soon as possible with the balance coming from the legacy fund.

The bookstall account which was built up by Roy Skellington has been transferred to the PCC account. It is a restricted account for the purposes of purchasing items and gifts for baptism services. It currently stands at £793.

Throughout 2019 we had various methods of collections for charity totalling £4028.

From PCC funds: Support for The Ark £660, HOPE roof £74 + £76 from collection.

Christian Aid was supported with Christian Aid week and appeal : Total £381.

PCC met the running costs for hosting and helping with:

Cath Crane's concert for Christian Aid £500; Christian Aid Quiz £877;

Concert for Men in Sheds £235;

Christingle Service for the Children's Society £297.

The Royal British Legion £400 from the Remembrance service + Collection boxes.

Gedling Christmas Tree lights on – refreshments served in church.

The Ark received £500 from the Children's Carol concerts and the joint Carol concert.

Ride and Stride donations raised £32.50 for Historic Churches Trust;

From the Gift Service new toys and vouchers for the Great Notts Christmas Toy Appeal.

At the Harvest services food and toiletries were collected for Framework; the Food bank receives on going support and help from volunteers.

Our major expenses were:- £48,900 Giving for Ministry; £8187 for Organist and Parish Administrator; £4652 for utilities; £4486 on insurance; £3028 on stationery, printing costs, land line and broadband and £3656 on church maintenance; (Total increase: £606 on 2018)

Our income mainly came from:- Regular Planned Giving £41870, Income Tax return £11213; Weddings and Funerals £3937; Collections on the plate £4562; fund raising £5755 from coffee mornings and £2000 from the proceeds of Gedling magazine. (Total deficit on 2018: £6200).

We are struggling to find regular income to cover regular costs, with reduced planned giving and collection plate offerings, with consequently reduced gift aid return and reduced income from weddings. Bills have generally increased by 2% year on year and our Giving for Ministry share is also set to increase by 2% year on year.

Thank you to everyone who has contributed to the costs of running All Hallows in whatever way they can. However, new regular givers and encouragement for increased giving will be necessary in order to continue to meet our commitments within the Deanery.

I would recommend to you that Mr. D G Hollingworth of D&D Accountancy Services, Ilkeston is re-appointed to examine our books again next year. They offer an extremely friendly and helpful service at a very reasonable rate, which they see as part of their Charitable Giving.

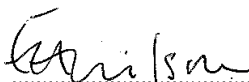

Independent Examiner's Report

To the PCC of All Hallows Church, Gedling,

We report on the accounts for the year ended 31st December 2019 which are set out on pages 1 to 9.

Respective responsibilities of the PCC and the Independent Examiner

The PCC are responsible for the preparation of the accounts. As members of the PCC you consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is our responsibility to

- examine the accounts under section 145 of the 2011 Act;
- follow the procedures laid down in the General Directions given by the Charity Commissioners section 145(5)(b) of the 2011 Act; and
- state whether particular matters have come to our attention.

Basis of Independent Examiner's Statement

Our examination was carried out in accordance with the General Directions given by the Charity Commission.

An examination includes a review of the accounting records kept by the PCC and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters.

The Secretary and Treasurer of the PCC was Mrs Eleanor Wilson.

At the 2019 APCM four people were elected: Graham, Steve, Orla and Pat. This left one vacancy on the PCC from 2019, four

vacancies from the 2018 intake and two vacancies vacancy from 2017 intake. Many thanks go to Anthony Grove, Kathy Northern and Bev Salmon as they come to the end of their term on the PCC. We look forward to welcoming five new members to the PCC in 2020.

There were a number of resolutions presented at the APCM in 2019.

Resolutions to PCC

1. Keith Hollingworth asked what was being done with the kneelers currently stored above the vestry? *At the May PCC meeting this matter was referred to the Refurbishment group.*
2. Green Energy. Keith Hollingworth asked if solar panels could be installed. *This matter was referred to the Building Committee at the May PCC meeting.*
3. Church Office. Anthony Grove asked that the church office be considered for refurbishing. *Some areas have now been cleared of clutter in the office but due to the space available, without massive investment in extension work the office is as streamlined as possible.*

Other business throughout 2019

There were nine PCC meetings throughout the year. Mic chaired four meetings but due to his ongoing eye problems, was absent from March until September, when he was welcomed back on a phased return. The remaining meetings were chaired by the churchwardens: Rick, Dorothy and John. Anthony Giles chaired the April APCM.

Issues raised at the January PCC meeting set the scene for the rest of the year. This included the need for new notice boards, still ongoing. Plans for the One Life Mission driven by the Diocese and Deanery and reported by the Ministry team, took place 12-14th September. The new Garden of Remembrance Area driven

by the Building Committee was operational by 18th September, with all funds for flower vases, notices garden design coming from bequests. A Sexton was appointed and a book of remembrance was designed and created.

The urgent need for a new Audio system was raised in January and after some research and comparing quotes, by November a final quote of £13000 had been received which was to be put to PCC at the January 2020 meeting for approval. PCC was kept updated by the refurbishment group on the progress of the tea bar project and the funding available and by November, the conditions to complete the faculty approval were being undertaken with high hopes for work to begin early 2020.

PCC were kept informed of the work being done by leaders of Junior Church, which saw changes in leadership from September. Regular updates were received from the Friends of All Hallows, the Pastoral Team, Memorial Hall and Deanery. A letter of thanks was given to Brian Hemming who has been voluntarily maintaining and improving the looks of the churchyard, which is still waiting the arrival of a new shed and hand rails – saga continues!

ASSOCIATE PRIEST REPORT

2019 has been a tough year for us all with Mic's long-term sickness and my bereavement after the death of my father in March and the ongoing care of my mother, with all the associated extra commitments. I know that I am so blessed to serve in All Hallows Church where I have the maturity of your prayers and loving understanding. Thank you from the bottom of my heart for your love to me this year.

Whilst Mic has been away, I have been delighted to hold the fort together with Keith Williams, Maureen, Margaret and John; Churchwardens Dorothy and John and Lorna and Steve.

At the top of the year I continued to offer Sunday Lunches and lead our Vestry confirmation group until April when Graham Thompson and James Sinclair were confirmed by Bishop Paul in St Mary's in Town and Bill Cox was confirmed by Bishop Tony in St Wilfrid's Calverton in May.

During Lent John Tattersfield and I led one of the All Hallows/Gedling Road Lent Groups; in Holy Week I exhibited my Abstract Stations of the Cross and led the Easter Triduum, the four major services associated with Easter, one of which was Healing Ministry in the revived Holy Saturday Liturgy.

Whilst Mic was away, we continued with our Ministry Meetings; I took assemblies in AH School, wrote many letters in support of parents' applications for the school, visited the sick, gave Home Communion, prepared adults and children for baptism, conducted funerals and the major services on Sunday and Wednesday.

Between September and December I prepared my Ministerial Development Review (read examination) for the Diocese - results still pending. October saw our joyful Pet Service.

In November I led a Quiet Day at Holy Cross Convent Costock and painted The Gedling Nativity for the Village Green.

ASSOCIATE PRIEST (RETIRED) REPORT

My official designation is that I am a retired priest with the Bishop's permission to officiate. I am proud to be able to do that with a ministry that centres around the Eucharist.

Over this year I have officiated at the 9.30 am service an average of once a month and a similar frequency on Wednesday mornings here at All Hallows, with some occasional cover at Holy Trinity, Lambley. I also regularly take monthly Sunday Eucharist in St George's, Netherfield and a few on Tuesday

mornings there. In addition there are occasional services that I officiate at when necessary: funerals, baptisms and weddings. I also, as the need arises, take services very occasionally at other churches, usually within the Deanery.

I continue to feel blessed also to be part of a ministry team, led by the Rector, that is both encouraging and talented; and appreciate very much the encouragement and support I am given by the congregation. Thank you to everyone for that. I am anticipating continuing in this way for another year or so.

FRIENDS OF ALL HALLOWS REPORT

The Friends are a group of 58 paid up members and 7 life members with a committee of twelve people whose remit is to organise events to raise funds for projects directed by PCC.

Fewer events were specifically organised by the Friends in 2019 compared to previous years. However, with the exception of January, the committee were involved with assisting in publicity, helping to organise and to provide refreshments for a number of events every month in 2019. Charities such as Christian Aid, Men in Sheds and the Royal British Legion were supported.

For church funds, events such as coffee mornings, summer fair, Gedling Gala and the Christmas Bazaar plus the All Hallows Audio System were supported. Members were also on hand throughout the One Life weekend to serve refreshments and welcome visitors to church.

As a Friends group, a Jumble Sale in May raising £400, a Fashion show in September raising £500 and a soup and roll lunch in October raising £250 were organised with all funds going towards the tea bar project. Ted continued to present his talks to various organisations throughout the year donating his fees to the Friends account. Funds directed to the Friends account were also received from the sale of preserves, the Ride & Stride sponsorship and membership subs.

The AGM in 2020 will see changes in the officers as Eleanor, Maureen and Ian have expressed their desire to stand down. Maureen Staniford rejuvenated the Friends in 2013 to raise money to fund the replacement of pews with chairs and to inspire fund raising efforts for the tea bar project. Katherine Crossley has been instrumental in gaining access to grant funding for both projects. To date £16000 has been pledged towards the tea bar project from outside sources and £36000 raised from Friends events.

Many thanks to all the members of the group who have worked extremely hard to raise funds for one project or another and have

attempted to organise events designed to bring the church and local community together and to create social events free from fund raising activities.

PHOENIX FARM OPEN DOOR PROJECT 'THE ARK' REPORT

It has been another very busy year for The Ark. Thanks to grant from Nottinghamshire Cooperative Society and Nottinghamshire County Council Community Improvement Scheme Capital Fund we have been able to refurbish the premises. This has enabled the building of a second advice office which will enable expansion of our services, new LED lighting, new and further redecorating. A grant for Nottingham City Transport has enabled us to reinstate the outdoor toilet and washroom which will compliment our newly landscaped garden and outdoor space. Our Garden Group have already created a beautiful outdoor space which can be used by Ark users for a variety of supportive activities. The Ark's registration with the Nottinghamshire County Council 'Place of Welcome' scheme is providing a haven for people in difficulty. Over one thousand advice appointments were made over the year and the Friendship, Craft, Lunch, Job Clubs and cafe continue to thrive. We have also kindly been awarded a three-year funding grant from the Methodist Church which will very much help with our salary costs.

The Ark would not exist without the fantastic support of its volunteers. We presently rely on the help of 13 volunteers who help in a variety of ways and we are in the process of carefully enabling volunteers to support in an advice role. It is with great sadness that I have to report the passing of Margaret Moore, a much loved and valued volunteer and Trustee. Margaret was a founder member of The Ark and a great advocate for its work. I pass on our condolences to Margaret's family and friends.

Trustees are a legal requirement of a charity such as the Ark. However, their role goes much deeper than this. They provide stable support for the workings and wellbeing of The Ark and together the Centre Manager Joel, plans for its future development. Trustees also help with volunteering duties on a regular basis. We are always on the lookout for folk interested in helping either as a volunteer or trustee. If you are interested in helping in any way you can, please contact either Joel or one of the trustees.

Following the General election last December, I would like to take the opportunity to thank Vernon Coaker was all the support he has given to The Ark since its inception over 17 years ago. We wish him well and look forward to working with our new MP Tom Randall.

The Ark would not exist without the kind generosity of the many donations and grants it receives and I would like to thank all who have contributed over the past year. If you would like to contribute financially to the work of The Ark on a regular basis, information is available in church.

Finally, without the firm faith foundations that underpin the Ark, it would not thrive, and I leave the final words to Holy Scripture from the Book of Micah: 'He has told you, O mortal, what is good. REFURBISHMENT COMMITTEE REPORT

The Refurbishment Committee is a sub-committee set up by the PCC to provide it with recommendations on changes to the furnishings and fitments of the church building. This year it has been entirely concerned with preparations for the construction of the new tea-bar and toilets.

By the beginning of 2019, Bruce Bradley our architect had produced a Schedule of Works and a set of drawings defining the proposals for the construction of the tea-bar and toilets.

Historic England (part of English Heritage) were approached to ask for their views on our proposals and they replied in March saying that they had no objections.

At its March meeting the PCC agreed to apply for a faculty for building the tea-bar and toilets. The DAC (Diocesan Advisory Committee) agreed to our proposals in July and recommended that we consult with the Society for the Protection of Ancient Buildings who again had no objection to our proposals.

Three contractors were invited to submit their tenders and Bruce recommended that the tender from Arc Group at a cost of £78,189 + VAT should be accepted. Much of the VAT is reclaimable under the Listed Places of Worship Scheme. The PCC agreed to accept the Arc tender at its June meeting.

The Faculty was granted in October and was subject to conditions two of which required us to:-

- a) engage an archaeologist to carry out a watching brief on any excavations we might make, and for the DAC to agree to his Written Scheme of Investigation before starting work.
- b) engage specialist contractors to move the parclose screen and the sarcophagus and again for the DAC to agree their Method Statements before commencing work.

Matt Hurford has been engaged for the archaeology, Dr David Carrington of Skillingtons to move the sarcophagus and Arc

Group to move the screen. All of their proposals have been approved by the DAC.

A preliminary meeting with representatives of Arc Group was held in December and it is planned to start work in March 2020.

BUILDING COMMITTEE REPORT

The purpose of our group is to deal with minor repairs and improvements to the fabric of the church as well as deal with major changes. During the year we have met several times to review progress on projects and to deal with minor works including levelling slabs, clearing drains and servicing of equipment such as boilers and fire extinguishers. Much of this work is initiated without meetings and tackled on a need to make safe.

The quinquennial report by our architect gives us guidance as to the urgency of repairs and we are coming to the end of the present report period with some of the immediate work completed. Obvious signs are roof repairs to the Chancel flashings and the difficult job of locating gaps in lead work that have caused leaks over the north aisle. This appears to have been successfully achieved before the worst of the winter weather arrives.

One Faculty that has been completed after several year's negotiating with the Diocese is the establishment of a new Garden of Rest and two interments have been completed. A Book of Remembrance is now kept in church and records kept as to the numbered plots. Still not resolved is the positioning of a new shed and a final decision has to be agreed between the DAC and GBC Planning Department.

The major work of refurbishment in creating two new toilets and a Tea Bar is being handled by a separate group and the Faculty for most of the work has been agreed. The work is scheduled to begin in March 2020 and we would like to thank Ted White for his work in getting this project to the final stages. We would like to thank the unsung volunteers that help to keep the church and churchyard clean and tidy on a regular basis, Mick Pringle, Mick Simpson, Tom Carnell, Pat Yarnall, Ginny Snowden, Christine and Ben Ward.

DEANERY SYNOD REPORT

The All Hallows lay representatives, Rick Wilson, Eleanor Wilson and Janet Grinnell have attended three meetings during 2019. The meetings are held at different churches in the Deanery to enable us to visit other parishes and observe varying ways of delivering the Christian message.

All Hallows has been successful in paying our full share of 'Giving for Ministry', (formerly known as Parish Share) in 2019. This goal was achieved by 14 of the 18 parishes who make up the Gedling Deanery under the leadership of the Area Dean, the Reverend Anthony Giles, Vicar of Woodborough and the nearby villages. A new three-year financial plan starts in January 2020 but the previous method of calculation is being used so only a small rise will occur in the payment required in 2020.

In September we joined other churches in the Deanery in the Diocese-wide mission weekend called 'One Life'. This was led by the Archbishop of York, visiting events in Southwell and bringing a group of bishops from the north of England to visit the parishes. We welcomed Father Ben Bradshaw, Chaplain to the Bishop of Sodor and Man, as our preacher at an All Age Worship on the Sunday. Every parish was encouraged to have special events that weekend and we held an Open Church day on the Saturday which attracted old and new friends to heritage displays, children's activities, fellowship and an organ recital. In the absence of Mic Johnson, the All Hallows event was planned by our Lay Reader, John Tattersfield.

A discussion took place at the November Synod about supporting a charity for a three-year term. The All Hallows representatives spoke on behalf of 'The Ark' but the members votes went to a medical organisation in Malawi.

If the Deanery Synod interests you, All Hallows will be looking for three new representatives to be appointed for a three year term starting in June 2020. This entails nine synods over the three years and participation in conversations with members of local

parishes. Volunteers will be requested at the Annual Parochial Church Meeting.

GEDLING MEMORIAL HALL REPORT

2019 has been a year for starting major refurbishments to the Hall in an attempt to make the building fit for the future. The building has been suffering from damp issues mainly due the misalignment of footpaths that have been constructed by local authorities and developers around the length of the building. Having built up a health bank balance we were at last able to tackle firstly the roof which needed a new flat roof over the Blackburn Room, a new valley constructed over the kitchen, the removal of an old chimney stack and the replacement of several rows of decayed tiles over the widow side of the Hall. This was followed by a major piece of work to reconfigure the west end of the building.

This involved closing the hall for 2 months during the summer while the old stage which had become the Blackburn Room was gutted and a new floor level established giving level access throughout the building. At the same time a new multi access toilet was constructed and a purpose-built store and cleaner's room was created. The final restructuring was the making of a new entrance with a smart new door which was part paid for by a bequest and a personal gift.

There are still damp issues which need to be addressed and hopefully we can get the builders working on damp proofing walls in the spring. The main Hall floor also needs replacing along with the two boilers that give hot air heating and the foul water drains will need new pipework to avoid regular blockages.

There was much volunteer work involved in clearing up after the builders completed their work and our thanks go to Eleanor for keeping the premises in an excellent healthy condition as well as maintaining the accounts as our Treasurer. Regular checking is also done by Pat Yarnall and Mick Pringle.

The Hall is held in trust by the Church with 3 ex officio Trustees and 3 PCC appointed Trustees. The Management Committee also includes people elected at the Hall AGM in May. James Stapleton advises on health and safety issues but as the total number is 7 it would be helpful if additional active members could be involved. With the amount still to be undertaken the committee will have to look into gaining grants to achieve the final refurbishment.
