CHURCHWARDENS' REPORT

We have had an interesting yet challenging year with Rev Mic Johnson retiring at the end of June on health grounds. Despite this we have been fortunate in still having three Communion services most weeks, other churches are not so well served. Much of this is due to Rev Jean Lamb who has worked many extra hours and also to Rev Keith Williams ensuring that our regular services including weddings and baptisms continue.

This takes us to a massive THANKYOU to everyone for your continued support and encouragement during our Interregnum. We have enjoyed the services of several visiting clergy and we thank Rev Sally Baylis, Rev Philip Thomas, Rev Kurt Barron, Archdeacon Phil Williams and the Bishop of Sherwood, Rev Andrew Emerton who visited us to lead our 'First Communion of Christmas'

Despite being in an Interregnum, All Hallows continues to thrive. Our 'Messy Church' meeting each month is joyous and continuing to introduce the love of God to the young. Thank you to all those involved in this important ministry.

Wednesday's too are friendly and noisy with lots of folk visiting us each week to look round the church and to enjoy a cuppa and a chat. Thinking about visitors to All Hallows, we have good contacts with our local Infant and Junior school, they all arrange visits to church for their pupils to learn about the building and what happens here. We enjoy and learn from some very interesting comments and questions from the children. Christmas was especially busy with services in church for the children and parents of All Hallows School, Priory Road School and Willow Farm School

We were challenged in April by the local scouts and cubs, who needed to take part in a virtual St George's Day Service which would be relayed from Southwell Minster. I need to thank Bill Cox and Steve Hicking especially here who ensured that our technical side of this worked, however, there were problems with the sound quality from Southwell which was a disappointment. It was still good to have so many young people in church from several local scout and cub groups.

Other special occasions have included celebrating Queen Elizabeth's Platinum Jubilee, a concert by the Nottingham Boys' Choir, our Bazaar and Coffee mornings, the Gedling Christmas Tree lights switch on. Also the more serious occasions such as Remembrance Day where the people attending in church and at the local War Memorial increases each year.

ANNUAL PAROCHIAL CHURCH MEETING

Apologies were received from Keith Hollingworth, Pam Tunnicliffe, Noreen Burows, Margaret Hicking, Mick Pringle, Linda Rigby, Pat Taylor.

1. **Minutes of the last Meeting**: There were no points of correction and the minutes were accepted as an accurate record.

2. **Rector's Report**: As Revd. Mic Johnson had been absent since before Christmas 2021 there was no report. Those present wished him well.

3. **Electoral Roll Report**: There were 114 names on the roll having made three deletions and two additions.

4. **Election of Deanery Reps**. There are two vacancies to run for one more year, no prospective candidates came forward.

5. **Election of PCC members**. Graham Francis, Steve Hicking, Orla Mills and Pat Yarnall had completed their term of office. There were two nominations for member of PCC those being Paula Turner and Graham Thompson both had been proposed and seconded and were welcome onto the PCC. It was hoped that some of the members leaving may agree to be coopted for the next year as there was 12 vacancies for PCC members. Thanks were given to all who had served on PCC and who had worked with dedication behind the scenes for the good of All Hallows Church.

6. Treasurer's Report and Appointment of Independent

Examiner: A report and the Statement of Financial Activities and a Balance sheet for 31st December 2021 had been circulated in advance. Questions were invited from the floor. The accounts had been audited by Rachel of D&D Accountancy Services and were duly accepted.

Eleanor was thanked for work she had done. Eleanor recommended D&D Accountancy Services as the independent examiners for 2022 explaining that Rachel had offered a day of her work for free to keep the cost down. Rachel was thanked for her generous offer and the proposal was accepted.

7. **Reports from Church Organisations**: The reports were open for questions.

Dorothy thanked everyone who had contributed to the APCM Report and for the work that they had done throughout 2021. Special thanks was given to Dorothy for standing in as Office Administrator; to Revds Jean Lamb and Keith Williams for stepping up to keep services running in Revd Mic's absence.

8. **Resolutions to the PCC**

1. From Anthony Grove: A letter to be sent to Archdeacon Revd Phil Williams to ask that the position regarding Revd Mic's illness be made clear to members of All Hallows as it was unfair to all concerned that the situation be allowed to continue. He asked that the Archdeacon or area Dean be invited to speak to the congregation. There was agreement from those present that by sending the letter a formal complaint about process was being made.

2. Rick Wilson proposed that a Parish Administrator should be employed to reduce the pressure and work load on Dorothy.

3. Bill Cox suggested that information should be made available to explain the role and purpose of the PCC, Deanery and other workings of the PCC.

ELECTORAL ROLL REPORT

From 1st January 2022 to 31st December 2022 there were six deletions from the Electoral Roll due to the persons demise. There are 108 names recorded on the Electoral Roll.

The preparation of a new Electoral Roll for All Hallows Church will commence in 2025.

TREASURER'S REPORT

At the end of 2022 we carried forward a working balance of £4314

Our income mainly came from:- Regular Planned Giving £32387, Income Tax return £9287; Weddings and Funerals £7243; Birthday appeal £744. Collections on the plate £6502 and donations £360; PCC fund raising £2111 and £479 from floodlighting. This income pays for our regular bills and Giving for Ministry

We paid £41000 to the Diocese leaving a shortfall of £19804. We have not used our savings to supplement Giving for Ministry as we are expecting future expenditure of at least £13000 for planned Quinquennial work and further expenditure required for stone masonry work as outlined in the Quinquennial report. We have pledged to pay the Diocese £36,000 by the end of 2023.

Our other major expenses were: Insurance £4713; Organist £4152 No parish Administrator expenditure with many thanks to Dorothy Ritchie for volunteering time to manage the office work with a saving of £3650) ; utilities £3596; stationery, printing costs, land line and broadband £3000; church maintenance £3452.

Charitable giving

Our policy is to donate 1% of voluntary income to charity in 2022 we contributed \pounds 508 to the Ukrainian appeal plus a regular contribution to The Ark of \pounds 720 per annum.

• From the Gift Service new toys and vouchers for the Great Notts Christmas Toy Appeal;

• Donations for Bags of Blessings were organised and the Food bank receives on going support from donations.

Refurbishment funds

The Refurbishment fund is used for major projects, 50% of fund raising is sent to the fund, topped up with appeals for specific

projects, next year it will be for replacing the lights with LED bulbs. In Memoria funds and bequests are also directed to our Refurbishment fund.

Independent Examiner's Report

To the PCC of All Hallows Church, Gedling,

We report on the accounts for the year ended 31st December 2022 which are set out on pages 1 to 9.

Respective responsibilities of the PCC and the Independent Examiner

The PCC are responsible for the preparation of the accounts. As members of the PCC you consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is our responsibility to

examine the accounts under section 145 of the 2011 Act;

follow the procedures laid down in the General Directions given by the Charity Commissioners section 145(5)(b) of the 2011 Act; and

Basis of Independent Examiner's Statement

At the 2022 APCM in April, two new members were elected. This left three vacancies on the PCC from 2022, four vacancies from 2021 and five vacancies from 2020. We now thank those coming to the end of their co-opted one year term on the council: Graham, Steve, Pat and Bill for the input they have given while in office. We look forward to welcoming five new members onto the PCC in 2023 and possibly co-opting members who may wish to stay on the PCC.

Three resolutions were presented at the APCM in 2022 which were resolved as follows:

To hand a letter from Anthony Grove to the Archdeacon regarding Diocesan process. This was done.

To employ a Parish Administrator. An advertisement was sent out but there were no responses. It was decided to wait until later in 2023 before trying again.

To encourage more people to join PCC with a written description of what the roll entails. This was done and is on the website and a booklet is available.

Other business throughout 2022

There were six PCC meetings throughout the year, Five meetings were chaired by John Rigby and one by Dorothy Ritchie. PCC were informed that Mic would be retiring due to ill health in June. He and Ani were wished well for the future.

Reports were received from the groups as classified under 'Wider', 'Younger', 'Deeper' and 'Business' with discussions taking place.

Meetings were also concerned with the business of appointing a new incumbent. This was facilitated by Archdeacon Phil Williams who led joint All Hallows and Holy Trinity PCCs in drawing out the vision of what type of person a new incumbent would be to fit with leading us into the future. From these meetings and questionnaires asked of the congregations, a Parish Profile was drafted. The post to be advertised in the Spring of 2023.

Other discussions included the contents of the Quinquennial report and the faculty for having plaques in the new Garden of Rest. PCC also approved the Building Committee's request for work to upgrade the lighting in the church to LED bulbs to reduce electricity costs.

ASSOCIATE PRIEST REPORT

Despite an impending Interregnum at the beginning of the year we carried on with our work to nourish and sustain the People of God through the Gift of the Eucharist, BCP & CW, both at All Hallows' and at Holy Trinity Church, Lambley. In addition I helped with Evensong, Evening Prayer on a Monday and the Mid Week Holy Communion Service. Funerals and visits were dealt with, Baptisms undertaken, Weddings celebrated. I was wholly supported by Church Wardens Dorothy Ritchie and John Rigby; musically by organist Steve Hicking, pastorally by Margaret Hicking and structurally by Eleanor Wilson. I helped wherever I could.

We sped on with new ventures to teach, promote and to consolidate the faith of God in Jesus Christ. The 'Children Calling' Course continued on a Monday Evening leading three people from one family to Confirmation in September 2022. During Lent we worked through the Living in Love and Faith Course established by the Church of England to investigate the reality of same sex relationships towards their blessing in the Church. In the Autumn we began two cohorts of "Follow Me.....", an Enquirers Course of the Christian Faith through the Pilgrim Programme.

We celebrated together at a whole Parish Party at St Alban's House on Sunday 24th April and went on to prepare and present our art and craft work which we had made through the long COVID months when we were isolated from each other in our two week CO:DID20 EXHIBITION, open to the public. The displays were excellent and were written up for the Diocese and for the Methodist-Anglican network Artserve.

The year ended with the Nativity Stall Holy Family scene now fully restored in situ by Gedling Community Christmas Tree, dedicated to supporting the work of the Ark Charity.

THE ARK ADVICE CENTRE

The Ark is based in Gedling and was established in 2002 by the then minister of Phoenix Farm Methodist Church, Reverend Louise Grosberg. The set up was supported by 4 other Gedling churches, Gedling Road Methodist Church, All Hallows CofE, St James Porchester CofE and Westdale Lane Baptist Church. All those churches continue to be involved today.

The charity has the aim of preventing poverty, alleviating hardship and serving the community in Christian love. The Ark is a truly ecumenical project that serves some of the communities most marginalised and deprived people. The Ark delivers a welfare rights advice service and community café which provides free tea and coffee. The welfare rights service provides over 1000 appointments a year. We also provide employment coaching job clubs to assist people into work. The Ark is a referral and collection point for foodbanks. As well as this we provide various social activity groups for people to come and enjoy hospitality and community with others. Over the last 12 months we have entered a partnership with Hope community hub at Carlton to deliver welfare rights advice at their centre.

As a result of the cost of living crisis we are seeing a wide variety of people coming for support to our service. We are working with other Nottinghamshire wide advice providers to increase the availability of our service. As part of this provision we are seeking to bring in specialised housing and energy advisors to offer appointments at the Ark.

MESSY CHURCH REPORT

Messy Church was launched in September 2021 with the help of Reverend Mic Johnson. It has grown and flourished over the last twelve months and we have a dedicated team of leaders and helpers. We would like to express our special thanks to Sue and Bill Cox who prepare and provide the wonderful food for the children and John Rigby who provides his legendary lemon drizzle cake each month. We would also like to thank Linda Freeman who leads the worship so well and Margaret Hicking, our lay minister, for all she does to support us. Our remit is to facilitate the spiritual development of the children and adults who attend and to promote and encourage families to attend other church services including Morning Praise and special services at key points during the liturgical year. We have a display board in church to share some of the children's crafts.

Messy Church is held once a month on a Saturday afternoon from 3- 5pm. It is usually held on the third Saturday of the month, with occasional variations. We have an average of 23 families who attend Messy Church, with between 25 and 35 children, and a similar number of adults most months. 47 children attended more than once between June and December 2022.

Messy church has a Biblical or liturgical theme each month; families meet in church to have fun with craft activities and participate in worship with songs, a short talk and prayers. This is followed by a light meal which families eat together.

We have a Messy church helpers Whattsapp group and have a monthly planning meeting which is usually attended by a core of 6-8 leaders. A larger group of helpers support activities on the day. We have 60 families on our Messy church WhatsApp group to keep families informed about events.

BUSINESS REPORTS

BUILDING COMMITTEE REPORT

Following a lengthy process, the hand rails by the office door were installed and in accordance with the quinquennial report, the office roof was resurfaced. The boilers had additional work and are now functioning as well as possible in a large draughty building without any insulation.

There was one official meeting in 2022 which saw new members welcomed onto the committee.

The business of the meeting was to look at the items raised from the Quinquennial report as List A (to be completed within two years) and to report on the regular service checks. The major maintenance work for masonry repairs and oak louvres requires faculties and advice from Bruce Bradley, the church architect. This work is ongoing.

Remedial maintenance is ongoing as the need arises, with thanks to Tom Carnell and Mick Simpson, to Steve Hicking for treating the wooden doors and outdoor benches and to Bill Cox for investigating the drainage and soakaways.

An electrical survey was carried out with only a few minor repairs required. The annual checks are in place for the Lightning conductor, PAT testing, Fire extinguishers and alarm systems. The tower clock is serviced and paid for by a grant from the Gedling Borough council with thanks for their continued support.

Bill Cox carried out a Fire Risk Assessment and met with the local fire officer. A few recommendations were made which included clear signage and smoke detectors. An awareness and evacuation training was carried out for 20 volunteers and will be reviewed annually.

The Building committee recommended to PCC that the lighting in the church building should be updated and replaced with LED bulbs to reduce electricity costs. This was approved and work will commence in 2023.

DEANERY SYNOD REPORT

Synod met via zoom on March 9th, and in person meetings on June 22nd and November 16th. 2022 saw the launch of the Parish Refresh process to discern the next steps in our strategy for growing disciples.

At each meeting, news from around the Deanery and from Diocesan Synod is shared. We hold discussions in small groups, and we pray for each other. We receive regular reports from Diocesan and General Synods.

Revd. Margaret Caunt retired from St Mary's Arnold and Revd. Mic Johnson from All Hallows Gedling and Holy Trinity Lambley; other churches in vacancy St. George's Netherfield, Carlton St John's, Colwick.

Lay Chair Tony Mellor stepped down and we thank him for his work. The post of Lay Chair is currently still vacant as is the post of Deanery Treasurer. Across the Deanery, we were able to meet just 67.8% of our share allocation, with three churches managing 100% despite recent difficulties, which was greatly appreciated. After significant discussion and consultation, we continued to trial apportioning Parish Share for 2023 on an 'offer based' approach.

2022 also saw the return of the popular Deanery Quiz. Area Dean John Allister made a demanding quiz master, and £190.20 was raised for Ukraine. There were 17 teams, and approx. 100 people had a very enjoyable evening. We plan to hold another very soon!

We are also pleased to have the services of Carsons to deal with maintenance work and deal with emergency repairs.

The hall income has been invested in improvements but has still left a healthy balance for future works. The tea bar is next in line for refurbishment.

It has been good to have the hall available for Coffee Mornings again and if you have not seen the 'new look' Hall do get in touch or come along to the AGM in May 2023. The Secret Garden which is accessed by the footpath Church View at side of the is now well established and is worth a visit in the spring.
