# Parochial Church Council of Holy Trinity Church, Lambley Notes to the Financial Statements

#### **HOLY TRINITY CHURCH 31.12.22**

#### 1 ACCOUNTING POLICIES

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.

#### 1(a) Funds

**Endowment funds** are funds, the capital of which must be retained either permanently or at the PCC's discretion; the income derived from the endowment is to be used as restricted or unrestricted income funds depending upon the purpose for which the endowment was established in the first place.

**Designated funds** are general funds set aside by the PCC for use in the future. Project funds are designated for particular projects for administration purposes only. Designated funds remain unrestricted and the PCC will move any surplus to other general funds. These funds have been designated towards the upkeep of the fabric of the church and towards the mission of the church.

Restricted funds represent (a) income from endowments which may be expended only on the restricted purposes intended by the donor, and (b) revenue donations or grants for a specific PCC activity intended by the donor. Where theses funds have unspent balances, interest on their pooled investment is apportioned to the individual funds on an average balance basis.

#### **Incoming Resources**

Planned giving, collections and similar donations are recognised when received. Tax refunds are recognised when the incoming resource to which they relate is received. Grants and legacies are accounted for when the PCC is entitled to the use of the resources, their ultimate receipt is considered reasonably certain and the amounts due are readily quantifiable. All other income is recognised when it is received. All incoming resources are accounted for gross.

### **Resources Expended**

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The diocesan parish share expected to be paid over is accounted for when due. All other expenditure is generally recognised when it is incurred and is accounted for gross.

#### 1(b) Fixed Assets

Consecrated and benefice property is not included in the accounts in accordance with s.10(2)(a) and (c) of the Charities Act 2011.

Movable church furnishings held by the incumbent and churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the church's inventory (The Terrier), which can be inspected.

## 1(c) Current Assets

Short - term deposits is cash held on deposit either with the CBF Church of England Funds or at the bank.
